## *USER GUIDELINES*

Welcome to Apserkaha Park on the beautiful Howard Prairie Lake. We hope you enjoy your stay. Please let us know if we may provide additional information. You can reach our office Monday – Friday 8:00 AM to 5:00 PM at (541) 774-8183. Below are a few guidelines intended to make your stay safe and enjoyable.

- While at the park, Renter agrees to comply with all Oregon State laws and Jackson County codes, rules and regulations must be followed at all times, as posted at the park.
- Upon vacating the facility, the renter agrees to leave the park and its facilities in a clean and organized manner. All garbage must be bagged and placed in provided receptacles/dumpsters.
- The kitchen must be left in a clean and organized manner, with all dishes and utensils washed and sanitized.
- The renter shall walk through the park with the Park Host upon arrival and departure from the facility to check the condition and cleanliness of the facility. If renter notices any condition needing attention prior to use, it is the renter's responsibility to inform the Park Host. The renter agrees to leave the facility in the same condition as found at the arrival. Any damage or excessive cleaning will be deducted from the security/cleaning deposit.
- Vehicles are allowed on existing roads only. No off-road vehicles are allowed to be operated in the park.
- It is the responsibility of the renter to provide all paper products, with the exception of toilet paper and paper towels.
- Renter is responsible for supplying all necessary first aid equipment and supplies.
- Jackson County Parks does not supply lifeguards. All swim areas are "swim at your own risk."
- **Serving of alcoholic beverages with kegs, trailer taps, and/or hard liquor is not permitted at any time; bottles and cans of beer and wine only by special use permit and may require an Oregon Liquor Control Commission (OLCC) license. It is the renter's responsibility to obtain this permit and provide a copy to the Parks Office.** Renter shall prevent the possession and use of illegal drugs in camp during the period of occupancy.
- Maximum capacity of Apserkaha Park is 120 overnight guests. Renter is responsible for ensuring this occupancy limit is not exceeded.
- Sorry, pets are not allowed in the cabins. Pets are allowed in the campground and are required to be secured by a leash and not left unattended.
- No amplified bands are allowed. Public address systems, DJ's, home stereos, portable stereos, or any other sound equipment must have prior written authorization by the Parks Department. Authorization is to be on the reservation form with the supervising rangers' initials. This form is to be presented to the park staff on the day of the reservation. Authorization may be revoked at Park Ranger's discretion.
- Firewood or briquettes are not provided. Fires are allowed in fire rings, barbeques or grills. Must be contained within ring – no overhanging wood. Please do not leave a fire unattended or leave before extinguishing any fire. Dispose of hot briquettes in existing fire pits or barbeques and extinguish.
- Discharging of firearms, fireworks, weapons, or explosives is prohibited in the park.
- Due to difficulty in cleanup and hazard to wildlife, we ask that no hay, straw or rice be brought into park.
- While the Jackson County Parks Department cannot be responsible for lost or stolen property, anything found will be turned in to the Parks Office. Inquiries may be made by telephoning the Parks Office at (541) 774-8183 Monday - Friday between 8:00 AM and 5:00 PM.
