Filing Period: Begins **June 3, 2020** & ends **August 25, 2020** at 5:00pm

Filing Form: [SEL 110 Candidate Filing – Minor Political Party](#) with the Candidates Nomination Certificate executed by a party officer and notarized.

Nonaffiliated Candidates

A prospective petition may be filed at any time in order to begin the approval process that is required prior to collecting signatures. Candidates filing by petition must allow enough time for approval to circulate, signature collection and signature verification prior to the filing deadline of August 25, 2020.

Party Affiliation Deadline: A candidate cannot be registered to vote as a member of any political party as of **February 27, 2020**.

- 1. File Prospective Petition Forms:** [SEL 114 Candidate Filing – Individual Electors](#) and [SEL 122-Candidate Signature Sheet – Individual Electors](#) (without signatures)
- 2. Collect Signatures:** Upon approval, collect no less than 1,094 valid signatures. Signers must be active registered voters of Jackson County. *We suggest candidates collect at least 25% extra signatures.*
- 3. Complete Filing:** Submit signatures sheets and [SEL 338-Petition Submission - Candidate, Voters' Pamphlet](#) no later than **August 11, 2020**.
