Filing by Petition

A prospective petition may be filed at any time in order to begin the approval process that is required prior to collecting signatures. Candidates filing by petition must allow enough time for approval to circulate, signature collection and signature verification prior to the filing deadline of March 18, 2021.

- 1. File Prospective Petition Forms:** [SEL 190 Candidate Filing – District](#) and [SEL 121-Candidate Signature Sheet – Nonpartisan](#) (without signatures)
- 2. Collect Signatures:** Upon approval, collect no less than the required number of valid signatures (the lesser of either 25 signatures or 10% of the active registered voters in the district).
- 3. Complete Filing:** Submit signatures sheets and [SEL 338-Petition Submission - Candidate, Voters' Pamphlet](#) (in person or by mail) no later than **March 8, 2021**.
